

#### SUMMARY OF TOWN OF GUILFORD SNOWMOBILE LAW

Snowmobiles can only be operated on the shoulders and inside bank of the following Town highways but not on the travelable portion of such highways: Shumway Hill-White-Wahlberg Road; Aldrich Road; Ivan Greenleaf Road; Crandall Road; Smith Road; Old New York State Route #8 at Lathams Corners; Ken Stead Road; Blower-Miller Road; Frink Road; Gonzer Road; Phillips-Odell Road; Creek-Fred Smith Road; Fred Utter Road; Medbury Road; Campmeeting Woods Road; Rockdale Road; Old New York State Route #8 at Rockdale; East Guilford Cemetary Road; Brown Road; Allen Road; Keach (Keech) Road; North Pond Road; George Wade Road; Lake Road; Joslyn (Joslin) Road; Furnace Hill Road; Gospel Hill Road; Glovers Corner Road to Yaleville Corner Road; Charles Shapley Road; Union Valley-Cooper School House Road; Town Line Road; Searles Hill Road; Hamilton Road; Hohreiter Road; K. Parker Road; Junction Road; Charles Wicks Road; Ives Settlement Road; Hay Path Lane Road; Parker Road; Ken Stead Road from County Road #33 to Norwich Town Line; Miller Road from H. Miller's residence to Shumway Hill-White-Wahlberg Road; Hoffman Road (Northerly half) from Glovers Corners Road to Chiovaro's residence; Huckleban Road from Ives Settlement Road to Donald Savory residence; Huckleban Road from County Road #38 to Edward Davies' residence; Peter Stobbs Road from County Road #38 to Sutton's residence; Robb Ross-Robinson Road from Parker Road to C. Rolf's residence; the entire distance of Old Chenango County Road #35 at East Guilford, New York; Old Chenango County Road #43 in the vicinity of East Guilford, New York for its entire distance; Hohreiter Road (Guilford Town Road #13) from Chenango County Road #38 to Guilford Town Road #25; the entire distance of East Guilford Cemetary Road (Guilford Town Road #42).

Snowmobiles can travel on the travelable portion of the following Guilford Town Roads when unplowed and unused during the winter

months: Morgan Road; Schlafer Road; Parker-Smith Hill Road; Drachler Road; Ken Stead Road From County Road #33, to Shumway Hill-White-Wahlberg Road; Miller Road from County Road #33 to H. Miller residence; Hoffman Road (Southerly portion) from Glovers Corners Road to Chiovaros' residence; Peter Stobb Road from Glovers Corners Road to Suttons' residence; Robb Ross-Robinson Road from County Road #35 to C. Rolf's residence.

Operation is prohibited on a public or private sidewalk or walkway.

Operation is prohibited within three hundred (300) feet of a school during the school noon hour, school recess, or while children are going to or leaving school during opening or closing hours.

Hours of operation on any portion of a Town Highway is limited as follows: Operation is prohibited Monday through Friday from midnight until 7:00 A.M. Operation on Saturday and Sunday is prohibited between 1:00 A.M. and 7:00 A.M.

Liability Insurance is required if the snowmobile is operated on any portion of a Town Highway.

Before a snowmobile can be operated on any portion of any Town Road except one of the listed unplowed Town Roads above, appropriate and legal snowmobile signs must be posted along said Town Roads.

SNOWMOBILES MUST ALSO COMPLY WITH ANY OTHER NEW YORK STATE LAW COVERING THE USE AND OPERATION OF SNOWMOBILES. IF ANY PROVISION OF THE GUILFORD SNOWMOBILE LAW IS INCONSISTENT WITH A NEW YORK STATE LAW, THEN THE NEW YORK STATE LAW CONTROLS.
